# Letter from the President

**2017 was a year of incredible growth** and transformation at MACV. I am proud to report that our team, our partners, and our supporters are making progress on the mission to end Veteran homelessness in Minnesota. Our significant accomplishments include:

- A new home was built for Veterans with children from our partnership with the Builders Association of the Twin Cities Foundation and Lennar.
- The Home for the Holidays initiative provided hundreds of homeless Veterans a holiday meal and wrap-around services hosted by the Minnesota Twins and WCCO at Target Field.
- Our new Master Lease program was launched to provide Veterans with the most challenges to finding housing with apartments of their own.
- Three Minnesota regions, covering 40 counties, declared they have achieved the goal of functionally ending Veteran homelessness.

Most importantly, these stories of progress have brought us closer than ever to realizing our vision of ending Veteran homelessness in Minnesota. A Veteran with a family no longer

must wonder where they will go and how they will eat after their shelter stay ends. A Veteran who came to an event for only a hot meal left with hope and housing. A Veteran for whom no landlord would give a chance now sleeps in their own bed. A Veteran who refused to leave their community in greater Minnesota to go to the big city for help now can choose an apartment where they want to make their home.

While we all feel pride in this success, it quickly gives way to the determination that ALL Minnesota Veterans must have these opportunities. Our work in ending homelessness is not complete until every Veteran in Minnesota has a place to call home. Even then, our work will not be done, as we must ensure that no Veteran experiences even a single night homeless.

Ending Veteran homelessness in Minnesota is our organizational mission, but it is so much more than words on a logo. It is the guiding force behind our staff's passion. I am inspired by their dedication to finding a housing path and walking it with every Veteran that they serve.

Daily I am reminded that this mission is far greater than MACV's alone. Our partnerships

are paramount, and I am deeply moved by the support of the community. Those who choose to share their time and resources to partner in our mission are vital to ending Veteran homelessness.

My sincere thanks go to our staff, our partners, and most of all to the women and men who have served our nation. We will all share in the accomplishment when we have achieved our goal.

# WCCO – Home for the Holidays

*The mission of MACV is to **End Veteran Homelessness in Minnesota** by providing housing, employment, and legal services. We accomplish our mission by providing these services directly and in collaboration with community partners.*

This year, in partnership with WCCO-TV | CBS Minnesota and the Minnesota Twins, we provided a Home for the Holidays meal for our homeless Veterans with on-site supportive services designed to bring them back into housing stability. WCCO also partnered with MACV to raise funds via multiple telethons to aid in the sponsorship of a home for female Veterans, and to support our mission of Ending Veteran Homelessness.



# Benchmarks for Ending Veteran Homelessness

The United States Interagency Council on Homelessness (USICH) has adopted a vision of what it means to end Veteran homelessness, ensuring that it is a rare, brief, and non-recurring experience. This vision is accompanied by criteria and benchmarks for communities striving to achieve this goal by providing targets and an ongoing assessment for communities. The core criteria are:

- 1. The community has identified all Veterans experiencing homelessness.**
- 2. The community provides shelter immediately to any Veteran experiencing unsheltered homelessness who wants it.**
- 3. The community provides service-intensive transitional housing only in limited instances.**
- 4. The community has the capacity to assist Veterans to swiftly move into permanent housing.**
- 5. The community has resources, plans, partnerships, and system capacity in place should any Veteran become homeless or at risk of homelessness in the future.**

Currently, three Minnesota regions, covering 40 of Minnesota's 87 counties, have declared an end to Veteran homelessness using these criteria. These communities are Southwest MN, West Central MN, and Northwest MN.

MACV is in the unique position to lead the efforts of ending Veteran homelessness for the entire State of Minnesota. Our programs and services are designed to achieve this end. Providing Rapid Rehousing, Permanent and Transitional housing, along with the support of outreach, employment, and legal services, targeting the homeless and at-risk Veteran population, all move Minnesota closer and closer to the goal.

Declaring an end to homelessness is the goal, but not the end. Communities that have achieved the benchmarks have shared that maintaining the success is just as difficult, if not more so, than initially achieving the goal. Veterans will continue to have crises that could lead to homelessness. Without strong prevention services and continued efforts to very quickly house any Veteran that becomes homeless, progress will not be sustained.

With MACV's track record of successful programs, and building and maintaining strong partnerships, we can not only end Veteran homelessness in Minnesota, but going forward make our state a place where no Veteran is without a safe home to call their own.





# 2017 Statistics

## Key Findings

- **21%** of clients report dependent children in their household
- **17%** of clients report a felony conviction
- **44%** of clients report physical health issues
- **90%** of Minnesota counties had a Veteran become a new client of MACV in 2017
- Of Veterans served statewide, **48%** were in homeless situations prior to entering our programs, and **52%** faced imminent homelessness
- Homeless Veterans were housed by our program with an **89%** success rate, equaling **634** housing placements

## Leading Factors Resulting in Homelessness

- Lack of affordable housing
- Low income, unemployed, or underemployed
- Disability: Mental illness, physical limitations
- Lack of appropriate employment opportunities
- Abuse and domestic violence

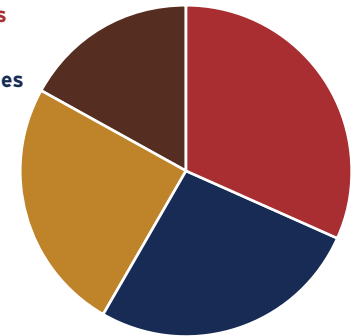

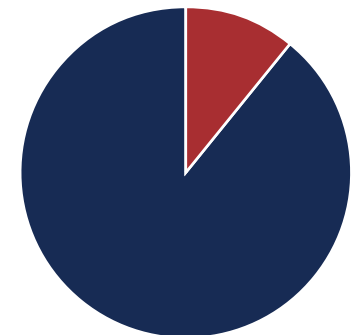

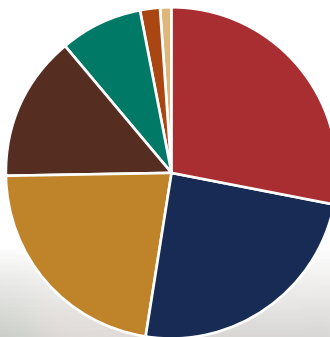




## Age Breakdown

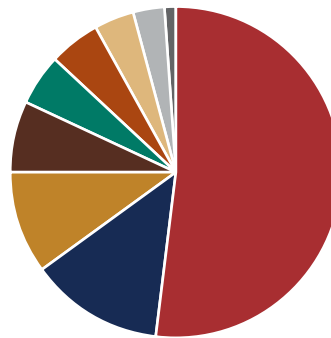

## Housing Status at Intake

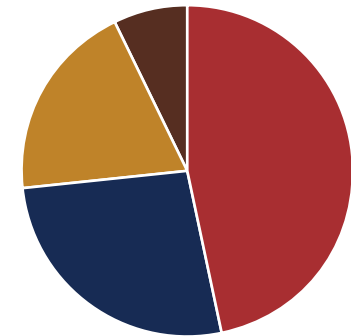

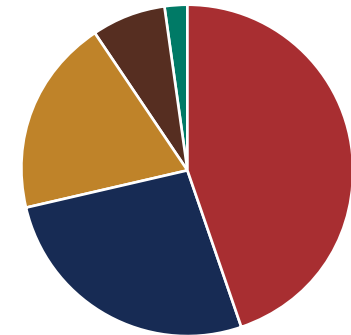

# Social Return on Investment Study (SROI)

What economic value is society gaining from the resources it is putting into MACV programming?  
For every dollar society puts in to assist the Veterans served by MACV, how much is it getting back?  
We already know the lives that MACV impacts and the successes it sees every day, but does it make economic sense?

## Measured Benefits

- Savings from avoided health care costs associated with homelessness
- Increased tax revenue from additional wages
- Increased wages from improved employment and health

## Measured Investments

- Direct cash assistance provided on behalf of participants
- Public funding from government sources
- Private funding from corporations, foundations, and individuals
- In-kind donations
- Services and benefits provided by partners

## Programs that Work

**For every \$1.00 invested in the Veterans served by MACV, society receives \$1.42 in return.**

Beyond the value to Veterans' lives, the community also sees lower health care, housing, and financial assistance costs. A 42% return on investment exceeds all economic expectations in both the non-profit and for-profit fields.

An investment in MACV is an investment in both Veterans and the community.

# Employment Services

**Employment programs** provide services that assist in reintegrating homeless Veterans into meaningful employment within the labor force.

MACV employment coordinators provide additional assistance by forging strong relationships with employers throughout the community.

With these relationships, and by helping Veterans update their resumes and work on employment skills, MACV employment coordinators are able to quickly and successfully place Veterans into full-time, living-wage employment.

## Employment Assistance

MACV provides employment services throughout Minnesota to aid Veterans with their employment search needs by providing supportive services, resume review, and development and career networking events.

By working closely with the staff at the Minnesota Workforce centers, a Veteran is connected with Disabled Veteran Outreach Program Staff and Local Veterans Employment Representatives, giving the Veteran an integrated team to work with as they conduct their employment search.

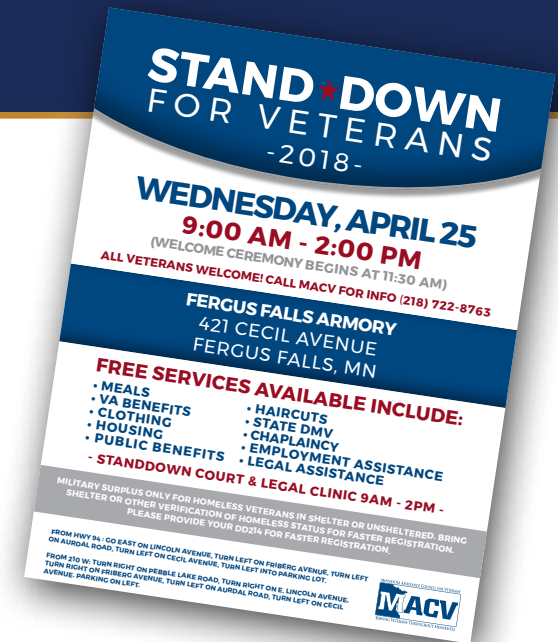
# Stand Down for Veterans

## Each Year, MACV Hosts Several Stand Down Events Across the State of Minnesota

*Providing at-risk Veterans with access to resources, services, and a sense of community.*

The original Stand Down for homeless Veterans was modeled after the Stand Down concept used during the Vietnam War to provide a safe retreat for units returning from combat operations. At secure base camp areas, troops could take care of personal hygiene, get clean uniforms, enjoy warm meals, receive medical and dental care, mail and receive letters, and enjoy the camaraderie of friends in a safe environment. Stand Down afforded battle-weary soldiers the opportunity to renew their spirit, health, and overall sense of well-being.

That purpose remains true today when MACV hosts a Stand Down for Veterans. At Stand Down events, MACV partners with local, state and federal organizations to bring many services to one location. This provides access to services for Veterans who are homeless, in crisis, or in danger of becoming homeless that may not otherwise seek out services. Our Stand Downs include a wide range of on-site services such as housing, legal, employment, assistance with Veteran benefits, Social Security, taxes, education, and many others.

## Permanent Supportive Housing

Long-term housing options providing on-site services to meet the unique needs of Veterans requiring long-term support.

- Paul and Dorothy Radichel Veteran Town Homes (Mankato)
- Duluth Veterans Place (Duluth)
- Linden Grove (St. Cloud)

## Transitional

Transitional programs are designed to assist Veterans to rapidly move into housing of their own. MACV offers several transitional housing options to include Structured Independent Living (SIL), and VA Grant, and Per Diem.

Through this support, Veterans gain the time and confidence to focus on work, school, and housing to allow for successful transition into independent housing.

## Master Leasing

Subletting apartments for Veterans and their families so they can build positive rental history and prepare for long-term independent housing success.

# New Partnership Creates Family Home

## At a Glance

- Located in St. Paul, MN
- Opened in 2017
- 5-bedroom family transitional home
- Length of stay up to 12 months
- Made possible through the generous partnership and donation from the Builders Association of the Twin Cities Foundation (BATC) and the Lennar Building Team



MACV recognizes through our years of experience that serving Veterans with families presents unique challenges. 21% of the Veterans that we serve have families with children. Studies show that homelessness significantly impacts children's educational achievements and leads to higher rates of homelessness as adults.

This house allows families to remain together rather than be separated in the shelter system. In addition, the location of this house provides improved access to transportation, employment, and schools.



Thanks to the partnership with the Builders Association of the Twin Cities Foundation, the Lennar Builders of Minnesota, and many of their independent contractors, MACV is addressing this issue with a new 5-bedroom home built through this collaboration.

*MACV is committed to ending Veteran homelessness in Minnesota, and does so through the generous support of our community partners.*





# Family Testimonial

Richard is a married 31-year-old Army Veteran with six dependent children who was honorably discharged from the service in 2013. When he got out, he started attending a for-profit school for culinary arts using the GI Bill. As he was attending school, it closed due to fraud relating to the use of the GI Bill for Veterans, and he struggled to find employment. Because of the loss of the housing stipend from the GI Bill and lack of employment income, Richard and his family became homeless in Arizona. He had a friend in Minnesota who told him that job prospects here were higher. Richard came to Minnesota in July of 2017 and secured a job within two weeks at the Red Cross working full time earning approximately \$2,300 per month. His wife and children came up from Arizona to join him. However, once they arrived, his friend could not accommodate the size of the family. They contacted resources in the community which led them to the Family Promise Homeless Shelter in Anoka, and then to MACV.

When Family Promise contacted MACV, they reported that they had a homeless Veteran family of 8, and wanted to know what MACV could do. MACV connected Richard to the VA to screen for a VA Housing Choice Voucher to address their long-term stability. Richard is now currently on the waitlist for a voucher, and MACV moved Richard and his family into the BATC Lennar Transitional Home. Once they are awarded a voucher, Richard and his family will begin a housing search to move into their own housing.

This assistance for Richard and his family could not have been provided without the support of the BATC Foundation in collaboration with Lennar to provide this transitional home.

## Timeline

- Lost employment in Arizona
- Came to Minnesota in June of 2017
- Checked into Family Promise Homeless Shelter August 2017
- Contacted MACV September 2017
- Moved into MACV transitional home October 2017



# Linden Grove

## At a Glance

- 37 units of affordable housing located in St. Cloud, MN
- Supportive services provider: Minnesota Assistance Council for Veterans
- 24 studio units
- 11 one bedroom units
- 2 two bedroom family units
- Community room
- Computer lab
- On-site laundry
- Picnic area
- Elevators
- Media room



Linden Grove Veteran Apartments features fully-furnished, spacious Studio, 1 and 2 bedroom apartment homes located in St. Cloud. The community includes a common room with kitchenette, TV lounge area and computer center, on-site laundry, supportive services and case management.

Overall, it is the goal of the project to assist Veterans to achieve greater social and economic independence through stable housing and services.

It is available to single adults and families in an alcohol-free environment. It offers on-site referral support for a broad spectrum

of services, including job search assistance and computer skills training, while providing Veterans close proximity to health care services at the St. Cloud VA Medical Center.

This approach grants the resident Veterans access to a wide variety of programs, specialties, and disciplines in the community in which they live.

# Paul & Dorothy Radichel Townhomes

Paul & Dorothy Radichel Veteran Townhomes are located at 700 Raintree Rd, Mankato, MN. The 11 one-bedroom units are Permanent Supportive Housing (PSH) for disabled Veterans that are homeless.

Each resident is screened prior to moving into the townhomes, and a Service Plan designed to meet the needs of each person is established. The Service Plans change as the needs of each individual changes. Each resident signs a lease and pays rent based on their income.

The Mankato Veterans' community has always supported our residents by providing a variety of meals, especially around the holidays. The local Elks Club participates by offering Thanksgiving meals, and visiting and playing cards with residents. The local Lyle C. Pearson Senior DAV Chapter #10 provides meals, gifts, and special events throughout the year for our residents.

A local motorcycle club donated the flagpole and lights, a local nursery donated sod and trees, and a local American Legion provided bedding and pillows.

*MACV greatly appreciates the donation of land from the William Radichel family that has allowed us to build this lasting legacy of service to our Veterans.*

# Duluth Veterans Place

## Program Information

- Located in West Duluth, MN
- Opened 2011
- 11 permanent housing beds
- 5 transitional housing beds

Program connects Veterans to resources in the community including:

- Mental and chemical health support
- VA benefits
- Vocational rehabilitation
- Employment services

Duluth Veterans Place has 11 permanent housing units, four transitional housing units, and one transitional handicap-accessible unit. MACV Duluth offices are co-located to provide on-site support for residents. Veterans and their case managers meet to develop and implement a plan to address each Veteran's unique needs.

This renovation project was conducted in collaboration between MACV and the Northern Communities Land Trust, and was completed in March 2011.

# Vetlaw Program

## Legal Clinics

The Minnesota Assistance Council for Veterans' Vetlaw Program hosts approximately 40 legal clinics per year that serve around 1,500 Veterans throughout the State of Minnesota. Vetlaw staff, with assistance from volunteer attorneys, paralegals, and law students, provide legal services in a wide array of civil and criminal law issues. Common legal issues include criminal expungement, debt collection defense, employment, and family law matters. In addition to legal professionals, representatives from child support, County Veteran Service Offices, and MACV case managers are available to assist our Veteran clients.

## Legal Partnerships

The goal of the legal partnerships is to provide low-income Minnesota Veterans with full-representation legal services designed to end or prevent homelessness without duplicating existing services. Our partners include: Legal Services of Northwestern Minnesota, Central Minnesota Legal Services, Legal Aid Service of Northeastern Minnesota, Southern Minnesota Regional Legal Services, Legal Assistance of Olmsted County, and several private practice attorneys.

**For 2017, Vetlaw had 279 different volunteers (many volunteered more than once), volunteering for a total of 2,517 hours. We responded to 2,488 requests for legal help.**

- Provide full representation, brief services, and advice to those without representation options
- Leverage law school and pro bono partnerships to provide representation services when pro se is not an option
- Provide referrals to out-of-state Veterans seeking legal assistance on Minnesota matters
- Provide referrals to Minnesota Veterans seeking assistance with interstate legal issues
- Identify at-risk and homeless Veterans in the community in need of supportive services (housing, financial assistance, jobs, etc.)

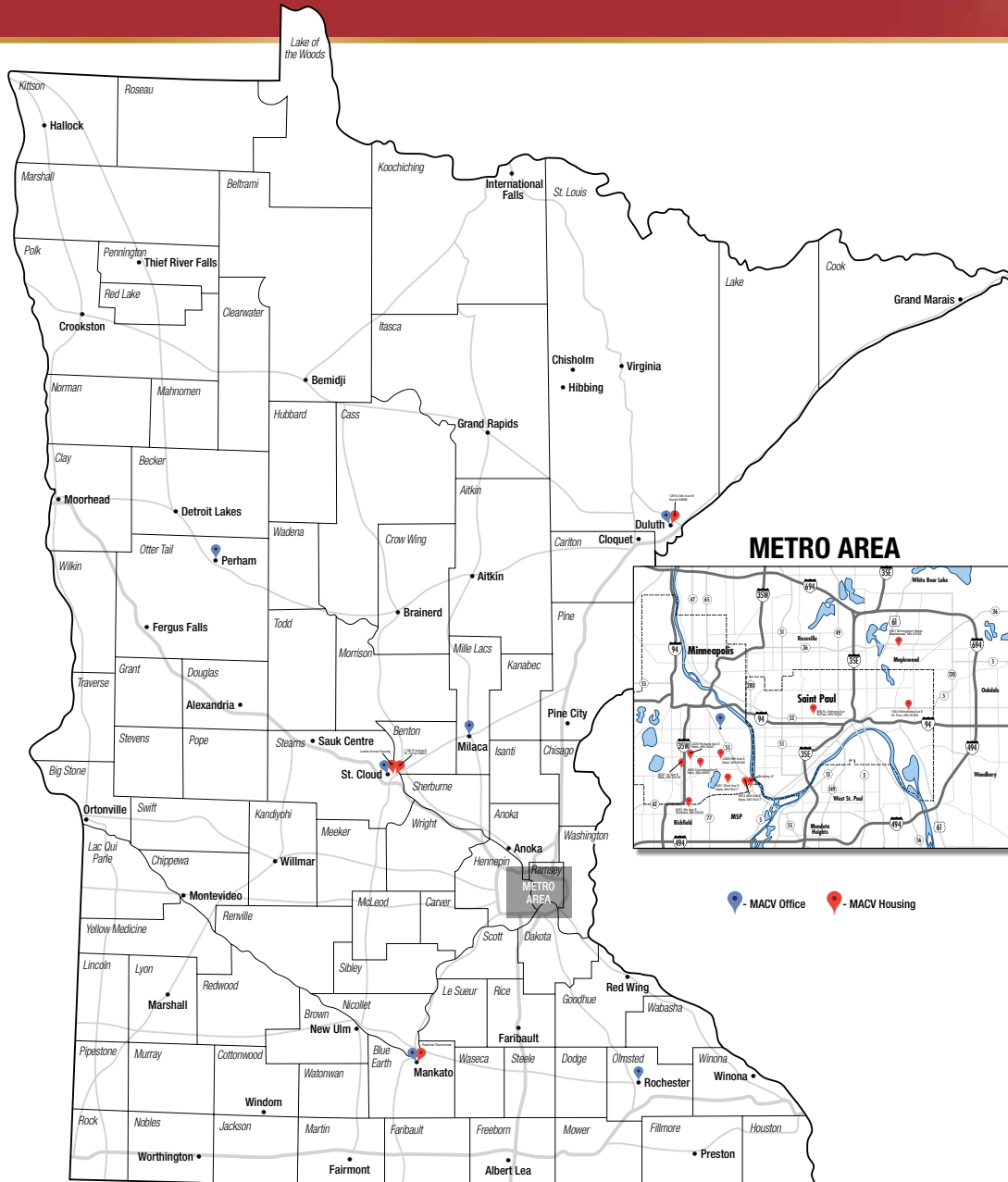
