St. Louis County has effectively ended homelessness among Veterans, Gov. Tim Walz announced in Duluth on Thursday. Courtney Cochran, who coordinates the effort for St. Louis County, said a list of 30 Veterans needing homes in 2019 has shrunk to three, and housing for that remaining number is being finalized. "We know there will always be more," she said, but Thursday's declaration means the county is placing Veterans in permanent housing within an average of three months, and that episodes of homelessness are rare and brief. 
MACV Employee Spotlight
